

# Upper Clutha Senior Citizens Club Inc.

Draft narrative.

On the 18th July, 1979, Dr Pezaro sent out many letters to Wanaka people requesting information/interest/assistance in forming a Senior Citizens Club. He also later sent out a questionnaire to the senior citizens of Wanaka to be returned by 28 May, 1980.

Meanwhile, a Steering Committee meeting was held on the 16th May, 1980, with 70 attending. Mr Chillis Young, chairman, Mrs Audrey Stuart, Secretary & a committee comprising Mr G. Duncan, Mrs J. Berthwick, Mrs C. Matthus & Dr Pezaro were elected, all acting in a temporary capacity only.

The inaugural meeting was held at the Wanaka Football Club rooms on the 30th May 1980. Mr J. Wilson was nominated for chairman, Mrs A. Stuart, secretary, & Mrs L. Grillies, treasurer.

And the Upper Clutha Senior Citizens Club was under way.

Initially meetings were held in the Community Council, 41 Brownston Street, where the use of two small rooms was offered. A partition between the rooms was removed, so there was room for about fifteen in "reasonable comfort". The Vincent County Council donated \$500.00 for the purchase of furniture for the rooms. First the rooms were open every day, but later to Fridays.

The Constitution was adopted on the 5th December, 1980

Annual subscriptions were set at £3 0.0 per single member & £5.0.0 for married couples, in May 1980. (This should be \$ - not £ - D. Jayne) ??

At the 2nd A.G.M, 4th June 1982 it was passed that the first Friday of every month meetings would be held in the Bowling Club rooms with a speaker, then subsequent Fridays held in the Council rooms for cards, films, games & talks. In his Annual Report, the president (Mr John Jayne) worried that although there were more than 60 members, attendance at meetings has been disappointing. "Where do we go from here?"

At the 3rd AGM, June 1983, it was thought that the Community Council be approached to get their views on a proposal that "we build a room onto the existing building". This is perhaps the first thoughts about the Club having its own rooms. This was held in abeyance when an offer was received from the Upper Clutha Rugby Union for the club to meet in their rooms free of charge.

However, a letter was sent to Lakes County Council asking for a site so that "we could make a start on rooms of our own".

In 1986 financial members numbered 82. Confiscated beer from the Police was donated to the club in 1989. It was sold for \$47.00.

From the first mention of building a home for the Club & finding a suitable site, it was six years of letters & negotiations, a plan drawn up for a building on a small reserve on the corner of Ardmore & Dunbarian Streets, battles over allocation of parking spaces, that finally, at the 9th A.G.M, 9th June, 1989, the current

President, Mrs Elsie Kane, said "it was judged expedient to shelve plans for our own rooms".

It was realised the club was too small to take on such an undertaking, & a really fat folder is in the club's archive, & bears testimony to the sheer dogged hard work & countless correspondence that went into this need for the club's own home.

At a club meeting at the Rugby rooms, 16th June 1989 Mrs Stan Kane, who is also a member of the Upper Clutha Historical Records Society, requested the club's important old records be deposited in the Records Room at the Council Rooms. These records are now held in a designated fire-proof room belonging to the Historical Records Society in the Wanaka Public Library, along with the early historical records of the wider Wanaka & Upper Clutha district. Also at this meeting, Mrs Linda Gillies completed 10 years as secretary, & was congratulated by a former president, Mr C. Rivers.

The 10th AGM was held on the 4th May, 1990. The Rugby Club decided to charge rental for their rooms — \$10 for Friday & \$5 for smaller card days. And a motion was carried that the meetings be held on the 1st & 3rd Fridays of the month. Card days would continue on Wednesdays. At a later committee meeting it was resolved to offer \$20 to the Rugby Club per Friday meetings.

In 1991 Ludwig Werner, with his wife Dorothea as pianist, started exercise classes for older people, many benefiting from this.

At a Committee meeting, Feb. 1992, a notice was

read from the Rugby Club saying that the rent would need to increase to \$30 a meeting. It was felt that was very hard, especially on card days, & a letter was sent to the District Club asking the cost of their rooms. In the following Committee meeting it was reported that the President of the District Club invited the Senior Citizens Club use of their premises at no cost. It was ideal - easy access, conveniences available - parking - free firewood - until 4.30 pm. Mr Chris Topson was the president. The Rugby Club "deserved thanks for their assistance over many years". The first function at the District Club was the Over 80's Dinner on the 29th May 1992, & to date, 2014, the Senior Citizens Club has enjoyed the pleasant venue for 22 years.

At the 13th AGM, 7th May 1993, a donation of \$100 was given to the District Club. Also, an application to the Armstrong Trust was given \$2,500 with which was purchased & installed, an Aquafit for the new community baths from the Senior Citizens Club. Membership in 1993 was approximately 90, with average meeting attendance about 30-40. The subscription remained at \$5 per person. It was suggested "we try & do some exercises at the start of each meeting".

In July, 1993, came a request from the District Club for an annual charge of \$200 + \$10 a day extra for Wednesday's cards. It was decided to accept the \$200 p.a. & leave card Wednesdays until next year. Then the D.C. decided not to charge us for this year & it was moved we give them a donation of \$200 in November.

Membership in 1994 - 75 — average meeting numbers - 35-40

Wanaka: It was a special day for the Upper Clutha Senior Citizens Club yesterday, as the group celebrated 21 years as an organisation.

Nearly 50 of the club's 73 members attended the function and while many would have liked to dance, they were content to tap their feet to the music.

Past secretary-treasurer Greta Bussell gave an overview of the 21 years, praising the foresight of Wanaka residents in establishing the group.

Recently the group changed its weekly luncheon meetings to twice monthly and Mrs Bussell said the venues had included church halls, the Wanaka Bowling Club, council rooms and rugby pavilions.

"At one time a great deal of work was done in an attempt to build our own rooms and there is still a building fund, so, maybe one day," she said.

Bus trips had proven successful and the group had visited areas from Akaroa to Stewart Island.

Teams had competed successfully at the Super Masters Games in Alexandra.

Financial grants during the years had helped purchase an equalizer at the Wanaka swimming pool, trips and a sound system.

With many retired people making Wanaka their home, Mrs Bussell said the club still had an important role in the community.

Towards the end of 1994 the new Constitution, under the guidance of Mr Chris Steven, Barrister & Solicitor, was accepted by the club, & in early 1995 it was decided the Annual General Meetings be held in April instead of June.

At the 16th AGM, 19th April 1996 it was moved that a piano be bought for \$1,500 from Mrs Wallis of Mosgiel, & the annual donation to the District Club be \$250.

A minute's silence was observed at the AGM on 18th April 1997 for Linda Gillies. Linda was the first treasurer when the club was established in 1980, serving in that capacity for the years 1980 to 1984, Secretary/treasurer 1985/1988, vice-president 1989/1990, & president 1991. A loyal & long-serving member of the club.

On April 27th, 2001, the 21st AGM was held, & it was decided to combine the 21st anniversary with the annual mid-Winter/Xmas Dinner on June 22nd. There were 49 members & guests attending and the Minutes of the first meeting were read, written 21 years ago. After Elsie Kane said Grace, a "delicious 3-course meal" was served, prepared by the Granadettes. An overview of the events of the past 21 years was written & read by Gretta Bussell. The two oldest members, Miss Lizzie Ironside & Mrs Dot Sherwin, cut the birthday cake.

The 22nd AGM, 12th April 2002, was a busy and successful year, reported Joan Morgan, President. On reading the report it was noted the donations given by the club during the year.

These were Age Concern, \$150, Friends of Dunstan, \$300, St. John's Ambulance Building fund, \$300, Wanaka Districts Club rental, \$300, and auditor, R. Hanan, \$50. Quite a considerable amount of money.

At the meeting of 26th April, 2002, members "stood in silent memory" of Jean Morgan, a much loved lady who had given so much to the club.

At the 23rd A.G.M. 28th March, 2003, the president, Peg McMillan reported that the membership stood at 69, with an average attendance at meetings of 30. The annual subscription would remain at \$5.00. The deaths were recorded of long-standing members Miss Lizzie Ironside, Mr Steven Fraser, + past presidents Mrs Jean Morgan and Mr Ken McDiamond, and the resignation of Mrs Margaret Cross, whose musical abilities were enjoyed for many years.

In August 2003 a Falls Prevention exercise class was started with instructor Christine Thomas which was "a great success". It was held at Elmslie House, with about 20 members.

At the 25th A.G.M. Elsie Kane, a foundation member, was awarded life Membership, on April 8th, 2005, + on June 24th, a combined Mid-Winter dinner + 25th Anniversary was held in the District Club-rooms. It was catered for by the Granadettes Leisure Marching Team.

Also at this A.G.M. Peggy McMillan, President, and committee members Elsie Kane, Gretta Bussell and Phyllis Marshall retired from committee.

In November, 2006, Iris Ryalls, secretary for 6 years moved to Waimate, & she was thanked & presented with a pot plant. In another mile-stone, February 2007, both Stan Kane & Myrtle Withington attained their 90th birthdays.

At a committee meeting on April 11, 2006 it was proposed that the long-running sales table be discontinued, & at a committee meeting on February 4, 2008, concern was voiced about the next A.G.M. as the President & Treasurer were stepping down & the club is finding it harder to fill these positions each year.

Lynne Fegan spoke to the committee about how the Community Networks could help fill in these positions & take a role in helping organise the speakers/entertainments for the club taking the stress off the older members.

Lynne then spoke at the meeting of March 14, 2008, & outlined this proposal to the members.

Copy of the proposal enclosed:—

At the 28th A.G.M. on April 11th 2008, it was explained that Lynne Fegan & Community Networks were nominated & accepted as Honorary Members of the club. Thus Interim Pres., Lynn Fegan, & interim Sec/Treas, Community Networks. It was unanimously agreed Comm. Net would take on Secretarial & financial responsibilities with Phyllis Whiteford as assistant in the Treas' role. A change of meeting day from Friday to Thursday was discussed. At a committee meeting on April 21, 2008, this was approved.

Shirley Boyes was Sec/treas.

In May 2008 the membership stood at 35

29th AGM May 28, 2009. President Lynne Fegan presented a wide-ranging Annual Report in which she wrote of the successful operating environment with Community Networks, the wonderful location for our meetings at the Wanaka Districts Club, & sincerely thanked the many volunteers who assist to make our meetings so enjoyable. The current membership is 53, of which 8 members are over 90, & 21 are over 80.

At the 30th AGM, June 10, 2010, Lynne Fegan indicated that this would be her last year as president, & it was decided that the position of Secretary/Treasurer be appointed from within the Committee. The membership is 56, & we now have 11 over 90 & 22 over 80.

At a committee meeting on 24th Jan. 2011 it was recommended the annual subscription be raised from \$5.00 to \$10.00, to be put to the next general meeting. It was also agreed that Lynne Fegan be available as president until a replacement could be found. The committee was urged to think about how the Senior Citizens Club should operate in future — are we moving forward? What do we want for senior citizens in the future? Who are we representing? What is our niche? And at a committee meeting, 20th June 2011, it was agreed that Lynne Fegan & Sarah Ballard would work towards finding a voluntary Administrator as Lynne will be stepping down as president in 2012.

It was discussed at a committee meeting on 21st November, 2011, that possibly a paid Volunteer/Co-ordinator could be considered, as Queenstown & Alexandra has, for approximately 5 hours/week, using some of our own money initially, then apply for funding to cover the position in future.

Committee meeting March 19, 2012; paid Co-ordinator - a contract & position description is now signed with Vivienne Fitzgerald on a 90-day trial period to ensure that we have funding in place for continuation of position. Vivienne, as co-ordinator, cannot act as president or treasurer, so now seeking people to take over these roles. As at May, 2012, membership stood at 60, & annual subscription \$20, confirmed at June AGM.

32nd AGM, June 28, 2012. Lynne Fegan retired as president at this meeting after giving the club 5 very productive years. In her annual report she thanked the many volunteers, the Wanaka Districts Club and the Lions Club who offered to fundraise for our club via the profits from their 2012 calendar. This raised the magnificent sum of \$6,500.00! July 23rd 2012 the president, Marilyn Fraser, was elected, treasurer Lynne Fegan, & Secretary Vivienne Fitzgerald, at the Committee meeting. Membership - 64.

33rd AGM, July 22, 2013. In her annual report, Marilyn Fraser, President, presented details of a successful year. The club adopted the "working/trading" name of "Prime Timers", hoping to boost the Club's public perception, and

drive up membership numbers, especially some younger people and more men. The Club's name for legal status remains Upper Clutha Senior Citizens Club Inc. The year's activities included day trips, social meetings every second Thursday and weekly exercise classes at the St John rooms. Our loyal volunteers were gratefully acknowledged - we could not function successfully without them. It can be noted here that the Granadettes catered for the Club from 1996 to 2008. Life membership was awarded to Gretta Bussell (95) and Enid Fraser (90). We lost both long-time members Stan and Elsie Kane. Elsie was a life-member. Membership stands at 68. Average attendance at Club meetings is 30. Average attendance on day trips and luncheons is 24.

34th AGM, July 17, 2014. Another busy and enjoyable year with about eight day trips away, and interesting speakers at our meetings. As always, volunteers are our dedicated people. Exercise and Tai Chi classes continue regularly and the tutors, Julie Stalker and Jeanette Forrester were thanked. After a discussion on the governance and roles of the committee the motion was passed that the committee can be reduced in size with each member given roles. Winton Davies was nominated to be the governance/management position.

At a committee meeting on December 11, 2014 it was decided to donate the piano to the Music Department, Mt Aspiring College. A final draft of the new Constitution has been sent to Felicity Hayman of Galloway, Cook

Allan for approval before it is registered with the Charities Commission. Felicity has agreed to act as our Honorary Solicitor. The increasing unsuitability of the Wanaka Districts Club as the venue for our meetings was discussed and the Bowling Club has been approached with a view to holding our meetings there. The exercise class has been poorly attended in the past year, so it was decided to cancel those in the meantime and have the weekly classes for Tai Chi which has become increasingly popular.

The Bowling Club proved unsatisfactory, so the meetings will now be held in the Presbyterian Church Hall, Tenby Street

Vivienne, our co-ordinator for the last three years is moving with her family to Tauranga, and her replacement will be Helen Millar. Vivienne has done wonderful work for us and we will all miss her very much indeed.

## Upper Clutha Senior Citizens' Club Incorporated - as at 31 January 2015

On 01 March, 2012 - the Upper Clutha Senior Citizens' Club took a huge step in moving from being a totally volunteer administered club, to contracting a part-time Co-Ordinator funded by the club.

Vivienne Fitzgerald was appointed to the position on a 90 day trial, and fortunately this moved to a long-term agreement. Consequently, Vivienne has advanced the club professionally during her tenure of the position, but is currently preparing to move to Tauranga, while transitioning her successor, Helen Millar.

Apart from organising meetings and social outings, the following has been achieved with Vivienne's invaluable assistance:

1. Funding Applications to: Central Lakes Trust; Lotteries; COGS; St Joan Trust; Otago Masonic Trust; Elsie & Ray Armstrong Trust; Gray & Olive West Trust; other smaller funders
2. Funders have provided: Wages; Training & Supervision; Stationery; Capital Purchases; Archive Project expenses; Exercise Class Tutors' fees; Travel Expenses for members' outings; Volunteer Expenses
3. Club Assets now include: Data Projector & Screen; DVD Player; Portable Sound System; Microphones - Lapel/Hand-held/Head-held + Microphone Stand; Laptop Computer, Printer & Filing Cabinet; Crockery; Defibrillator; Exercise Equipment
4. Administrative Matters: Updated Constitution; Charities Commission Status; Banking Online; Memorandum of Understanding with Community Networks (Alpine Community Development Trust)
5. Financial Matters: Club Funds of \$11000.00 have been able to be retained owing to astute application writing & Funders' generosity. It is to be hoped that we can secure 'sustainable' funding for our Co-Ordinator, as without a funded position it is likely that the club would not be able to operate with volunteer input only.
6. Club Name: The 'trading' name of 'Prime Timers' (with a modern green/blue logo) has been adopted as a better reflection of our membership. The Incorporated Society registration of 'Upper Clutha Senior Citizens' Club' has been retained for legal purposes.
7. Premises: The club has been meeting at the Wanaka Districts Club in Plantation Road for many years, but is moving in February, 2015 to the Wanaka Presbyterian Community Church Centre for twice-monthly meetings. This facility offers flat access, a commercial kitchen, steady heating/cooling, storage, and plenty of space to separate the tables for afternoon tea from the 'theatre' seating for meetings.
8. Club Liability: A 'Member's Contacts' form is completed & signed by all new members. This provides details on relevant health matters, contacts of relatives & friends, + a signed disclaimer for the club to ensure that members are responsible for all eventualities while enjoying club activities.
9. Volunteers: Without the generosity of volunteer's time, the club would struggle. Volunteers assist with meeting set-up; outings; hospitality; provision of refreshments.
10. Administration: This operates from the Co-Ordinator's home, but with a Post Office Box postal address
11. Professional Assistance: The club has an Honorary Solicitor, & Honorary Financial Reviewer
12. Archivist: Doreen Tyree (member) initiated an extensive Archive Project on behalf of the club. The precious records are stored at the Wanaka Library.
